### FROM THE CHAIR...

It is inspiring to reflect over the beginnings of this parent advocacy group and to realize that 10 years have gone by in service to Howard University and the wider community.

On a fateful day in the Fall of 1981, when I was a student in the University Without Walls at Howard University, I approached Dr. Sylvia Walker about being my academic advisor. The thoughts we shared that day led to the beginning of the Parents Advisory Committee (PAC) of the Center for the Study of Handicapped Children and Youth.

When Dr. Walker asked me to suggest members, my first thoughts were of Mazie Green Holland and Sylvia Ross--Sylvia as the mother of a special needs child, and Mazie as ardent advocate for us both. Mazie, several years before, had developed so much compassion and understanding of our needs that she provided a forum for us and other parents in her home so that information could be shared on a regular basis. Sylvia, Mazie, and I became the core membership of PAC. On December 14, 1981, the PAC had its first official meeting, with Mazie, Sylvia, myself, Dr. Walker, Dr. Willie T. Howard (then Dean of the School of Education--the parent school of the center), and several staff members of the Center.

At this meeting we laid the groundwork for our mission, planned this very newsletter, volunteered for parent workshops, and quite enthusiastically, you could say, joined the Center in serving the needs of handicapped children and their families.

Needless to say, none of this could have been possible without the overwhelming support of Dr. Walker and each and every wonderful PAC member.
